On motion of Mr. Montelongo, seconded by Mr. McCloskey, it was moved to adopt the following resolution:

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO COMPLETE AND SUBMIT THOSE DOCUMENTS AND AGREEMENTS REQUIRED IN CONNECTION WITH THE COMMUNITY WATER ENRICHMENT FUND (CWEF) 2018-2019 GRANT APPLICATION IN THE SUM OF \$79,200.00 TO THE STATE OF LOUISIANA TO ASSIST THE PUBLIC WORKS DEPARTMENT WITH REPLACEMENT OF WATERLINE ON EAST CAROLINA DRIVE TO IMPROVE THE PUBLIC WORKS DEPARTMENT'S ABILITY TO PROVIDE WATER SERVICE TO THE CITIZENS OF ST. BERNARD PARISH

WHEREAS, the Public Works Department is responsible to provide maintenance and repairs on the water and sewer system in St Bernard Parish; and,

WHEREAS, there is a need for the Public Works Department to replace cast iron waterline on East Carolina Drive; and,

WHEREAS, the purpose of CWEF is to assist local governments with grant funding, with no match or reimbursement required from the recipient or Parish, for rehabilitation, improvement, and construction projects on community water systems for eligible Parishes in the amount of \$79,200.00; and,

WHEREAS, the grant will allow the Parish to replace waterline on East Carolina Drive.

NOW, THEREFORE, BE IT RESOLVED by the St. Bernard Parish Council, acting as governing authority of said Parish

SECTION 1. That the St. Bernard Parish Council does hereby authorize the Parish President to complete and submit those documents and agreements required in connection with the Community Water Enrichment Fund (CWEF) 2018-2019 grant application totaling \$79,200.00 to the State of Louisiana to assist the Public Works Department with the replacement of waterline on East Carolina Drive to improve the Public Works Department's ability to provide water service to the citizens of St. Bernard Parish.


The Council Chair, Ms. Callais, cast her vote as **YEA**.
