On motion of Mr. Montelongo, seconded by Mr. Gorbaty, it was moved to adopt the following resolution:

A RESOLUTION ENDORSING A LETTER TO THE CAERNARVON INTERAGENCY ADVISORY COMMITTEE (CIAC) OPPOSING THE PROPOSED 2019 OPERATIONAL REGIME.

WHEREAS, on December 5, 2018, the Caernarvon Interagency Advisory Committee (CIAC) will convene to adopt the 2019 Operational Plan for the Caernarvon Freshwater Diversion, and

WHEREAS, it is the belief of the St. Bernard Parish Council that the current operation of the Caernarvon Diversion is causing injury to the Essential Fish Habitat in Breton Sound as established under the Magnuson-Stevens Fishery Conservation and Management Act.

NOW, THEREFORE, BE IT RESOLVED the St. Bernard Parish Council does hereby endorse the attached letter (Exhibit "A") to be submitted to the Caernarvon Interagency Advisory Committee (CIAC) opposing the 2019 Operational Regime.

Mr. Ellison:

The St. Bernard Parish Council, as governing authority of St. Bernard, is submitting this letter as a formal objection to the proposed 2019 operational regime of the Caernarvon Freshwater Diversion. As shown by the attached graphs depicting the level of salinity at a gauge located approximately 16 miles from the diversion outfall area the salinity is currently under two parts per thousand. At the same gauge in 2017 the salinity was over five parts per thousand.

This diversion is a salinity control structure and should be operated based on the salinity levels established to best maintain the Essential Fish Habitat. Maintaining a 500 cfs minimum flow is creating an environment in the basin that is detrimental to the industries that St. Bernard Parish relies on for its economic survival. Our oyster, shrimp, and recreational fishing industries are all seeing negative consequences based on the current operational regime.

With the combined effects of Mardi Gras Pass running uncontrolled, increasing the freshwater flow into the basin at a current and ever-rising rate of 17,900 cfs, additional freshwater is not necessary in this basin until that breach is repaired. This increase of freshwater flow has greatly reduced the salinity of these adjoining marshes injuring the historic seed ground of some of the oldest known oyster reefs in Louisiana.

In conclusion, we respectfully request that the 2019 operational regime be altered to remove the 500 cfs minimum flow of the Caernarvon diversion. Thank you for your consideration in this matter.




