BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, NOVEMBER 6, 2018 AT SEVEN O'CLOCK P.M.

On motion of Mr. Lewis, seconded by Mr. Montelongo, it was moved to adopt the following resolution:

RESOLUTION SBPC #1888-11-18

A RESOLUTION TO APPROVE THE CHENIER NATURE TRAIL PROJECT AND TO OBLIGATE MATCHING FUNDS TO LAND AND WATER CONSERVATION FUND PROJECT.

WHEREAS, the Parish is improving quality of life by developing park space in St. Bernard Parish; and,

WHEREAS, the project would create walking path and bike trail connection from Torres Park to the 40 Arpent Wetlands Observatory and further to the 40 Arpent Bike Path currently in development; and,

WHEREAS, any wiring covered in this project, or wiring done in the future on this site, will be placed underground; and,

WHEREAS, the Parish's Comprehensive Plan, the Complete Streets Plan, the recently adopted Bikeway & Pedestrian Plan Update and Integrated Water Resources Management Plan promotes development of the nature trail.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, does hereby agree to obligate the funds or services stipulated below to satisfactory complete the following project and thus become eligible for the U.S. Park Service Land and Water Conservation Fund financial aid of 50% of the estimated or actual allowable cost, at the completion of said project. St. Bernard Parish Council also states that sufficient funds are on hand, as of this date, to fund said project as follows:
