## RESOLUTION SBPC #1937-04-19

A RESOLUTION TO MAKE AN INTERIM APPOINTMENT TO FILL THE VACANCY IN THE OFFICE OF CONSTABLE WARD C FOR ST. BERNARD PARISH.

WHEREAS, Beau Bowman resigned as of April 8, 2019, creating a vacancy in the Office of Constable, Ward C, and;

WHEREAS, the unexpired term of said office exceeds one year, and;

WHEREAS, Ward C is wholly located within the boundaries of the Parish of St. Bernard.

NOW, THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the Governing Authority, does hereby proclaim the following:

**SECTION 1.** That Tina Micheu is appointed as Interim Constable Ward C.

**SECTION 2.** That a Special Election will be called for October 12, 2019, Primary and November 16, 2019, general with qualifying dates August 6, 7, & 8, 2019.

**SECTION 3.** That the Clerk of Council shall forward certified copies of this Resolution by certified mail within twenty-four (24) hours to the Louisiana Secretary of State, and the St. Bernard Parish Clerk of Court in accordance with Louisiana Revised Statutes 18:602.
