EXTRACT OF THE OFFICIAL PROCEEDINGS OF THE COUNCIL OF THE PARISH OF ST. BERNARD, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD IN THE COUNCIL CHAMBERS OF THE ST. BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, NOVEMBER 19, 2019 AT THREE O'CLOCK P.M.

On motion of Mr. Gorbaty, seconded by Ms. Callais, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #1996-11-19

A RESOLUTION AUTHORIZING ACCEPTANCE OF A 2019 LOCAL ROADS SAFETY PROGRAM GRANT FOR THE ST. BERNARD PARISH SIGNING AND STRIPING PROJECT (PROJECT H.0009175 SUPERSEDING 2013 GRANT) IN THE MAXIMUM AMOUNT OF \$417,800.00.

WHEREAS, the federal transportation act, known as The Moving Ahead for Progress in the 21st Century Act (MAP-21), authorizes federal funding for highway safety improvements in the State of Louisiana through a number of State grant programs; and,

WHEREAS, these highway safety grant programs in Louisiana are administered by the Louisiana Department of Transportation and Development (DOTD); and,

WHEREAS, St. Bernard Parish Government approved a grant amendment under the re-designed Local Roads Safety Program in February, 2019 increasing our 2013 grant to \$180,000.00; and,

WHEREAS, St. Bernard Parish adopted the 2017 St. Bernard Parish Bikeways and Pedestrian Plan and requested DOTD consider signing and striping improvements to further implement the Parish's plan as part of the safety improvements constructed under their program; and,

WHEREAS, DOTD expressed a willingness to consider these recommendations and completed a feasibility study to evaluate which improvements could be eligible under the revised DOTD program; and,

WHEREAS, based on the completed feasibility study, DOTD will include 22 streets for safety signing and striping in its program and over 18 miles of bikeway improvements as shown in the Parish's plan; and,

BE IT FURTHER RESOLVED, the St. Bernard Parish Council, does hereby authorize the Parish Responsible-in-Charge to execute all grant documents required in connection with this Local Roads Highway Safety Program Grant including the revised Funding Commitment Letter.


