On motion of Mr. Luna, seconded by Mr. Gorbaty, it was moved to **adopt** the following resolution:

## **RESOLUTION SBPC #1995-11-19**

A RESOLUTION APPROVING PURCHASES FOR THE "100 TREES OF SUMMER" PLANTING PROJECT.

**WHEREAS**, "100 Tress of Summer" Planting Project is fully funded with donations made by businesses and residents of St. Bernard Parish to the Tree Fund; and,

**WHEREAS**, Councilmember Luna is seeking approval from the Council to purchase 63 of the 100 trees for the project with the donated money that is estimated to cost up to \$3,100.00; and,

**WHEREAS**, Councilmember Luna is also seeking approval from Council to purchase mulch for the project with the donated money that is estimated to cost up to \$200.00; and,

**WHEREAS**, Councilmember Luna will seek approval to purchase the 37 remaining trees as they become available and any other materials needed.

**NOW THEREFORE BE IT RESOLVED**, the St. Bernard Parish Council, does hereby approve the purchase of trees for the "100 Trees of Summer" Planting Project.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


