On motion of Ms. Callais, seconded by Mrs. Alcon, it was moved to adopt the following resolution:

RESOLUTION SBPC #1997-11-19

A RESOLUTION AUTHORIZING A GRANT APPLICATION TO THE FY2019-20 LOUISIANA LOCAL GOVERNMENT ASSISTANCE PROGRAM IN THE AMOUNT OF \$165,700.00 FOR THE JUDGE PEREZ SIDEWALKS PROJECT.

WHEREAS, the FY 2019-20 Louisiana Local Government Assistance Program (LGAP) is a State of Louisiana grant program designed to provide financial assistance in support of projects which improve the health, safety and quality of life of the residents in selected geographical areas; and,

WHEREAS, St. Bernard Parish adopted a new Bikeway and Pedestrian Plan in 2017 that recommends sidewalk improvements along Judge Perez Drive as a priority project in order to facilitate pedestrian travel and transit access; and,

WHEREAS, the Louisiana Local Government Assistance Program has issued a call for grant applications for its 2019-2020 State Program with grants not to exceed \$165,700.00 with no local matching funds required.

NOW THEREFORE BE IT RESOLVED that the St. Bernard Parish Council, does hereby authorize the submission of a FY2019-2020 grant application to the State of Louisiana Local Government Assistance Program in an amount not to exceed \$165,700.00 for improved transit access and infill sidewalks along Judge Perez Drive between Jean Lafitte Parkway and Village Square; and,

BE IT FURTHER RESOLVED, that the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to sign and submit all required grant applications, Cooperative Endeavor Agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with the LGAP Program.


