BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, DECEMBER 3, 2019 AT SEVEN O'CLOCK P.M.

On motion of Mr. Luna, seconded by Mr. McCloskey, it was moved to **adopt** the following resolution:

## **RESOLUTION SBPC #2001-12-19**

A RESOLUTION REQUESTING ADMINISTRATION TO PAY THE FEE THAT IS IMPOSED ON RESIDENTS WHO PAY THEIR WATER AND SEWER BILL ONLINE BY ELECTRONIC CHECK OR RECURRING AUTO-DRAFT PAYMENTS OF SAID BILL.

**WHEREAS**, on November 1, 2019, St. Bernard Parish Government began using Point & Pay, a service in which residents of St. Bernard Parish can pay their water and sewer bill online; and,

**WHEREAS**, residents are charged a small fee for paying their water and sewer bill online. Said fee goes directly to the vendor, Point & Pay; and,

**WHEREAS**, under the previous payment system, residents were not charged a fee for paying their water and sewer bill online; and,

**WHEREAS**, administration should pay the small fee imposed on residents who pay their water and sewer bill online by electronic check or by recurring auto-draft payments; and,

**WHEREAS**, it is estimated the payment of said fees for residents who pay by electronic check or by recurring auto-draft payments is \$30,000 per year; and,

**WHEREAS**, costs will be defrayed once paperless billing goes into effect.

**NOW THEREFORE, BE IT RESOLVED**, that the Parish Council, the governing authority, hereby requests that Administration pay the small fee imposed by Point & Pay on residents who pay their water and sewer bill online by electronic check or by recurring auto-draft payments.
