BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, JANUARY 21, 2020 AT SEVEN O'CLOCK P.M.

On motion of Mr. Everhardt, seconded by Mrs. Alcon , it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2018-01-20

A RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (DOTD) TO LOOK INTO PLACING RUMBLE STRIPS AT THE INTERSECTIONS OF LA 46 AND LA 39 AND ALSO LA 36 AND LA 300.

WHEREAS, from 2008 to present there have been 57 total accidents reported with 2 of those being fatalities; and,

WHEREAS, due to the number of accidents and injuries that occur at these two intersections, LA 46 & LA 39 and LA 36 & LA 300, St. Bernard Parish Government is requesting that LA DOTD help and assist to ensure the public safety with this matter.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, does hereby request LA DOTD to look into placing rumble strips at the intersections of LA 46 & LA 39 and LA36 & LA 300. This resolution is to be forwarded to Scott Boyle, Assistant District Engineer of Maintenance with LA DOTD.

The above and foregoing having been submitted to a vote, the vote there upon resulted as follows:
