Americans with Disabilities Act Advisory Committee By-Laws

Article I. Name

This board shall be known as: "The Americans with Disabilities Act Advisory Committee" to the St. Bernard Parish Council, hereafter referred to as "ADA Advisory Committee".

Article II. Purpose

The ADA Advisory Committee will advise the St. Bernard Parish Council on the implementations of the Americans with Disabilities Act of 1990 mandates. The ADA will advise the Parish Council on the removal of barriers to the disabled citizens of St. Bernard Parish in the areas of employment, recreation, transportation, public accommodation, communication, and housing in both the public and private sectors of St. Bernard Parish.

Article III. Board Structure

The ADA Advisory Committee shall consist of five (5) members appointed by the St. Bernard Parish Council. The appointment will be for the term of the St. Bernard Parish Council. Any Board Member missing three (3) consecutive meetings, other than for sickness or unavoidable circumstances, shall be dropped from the Board and replaced. The ADA Advisory Committee shall consist of a Chairman (elected by the board members) and Vice Chairman (elected by the board members). The St. Bernard Parish President shall provide an Administrative Liaison to the ADA Advisory Board. The St. Bernard Parish Council shall provide a recording secretary for the purpose of recording all public meetings of the ADA Advisory Committee as part of the St. Bernard Parish public record. Resignation from the Board shall be in the form of both a written statement and verbal statement to the Administrative Liaison and to the committee. Terms to be 4 years and shall follow the elected official terms beginning January 2020.

Article IV. Duties of Committee Members

A. Chairman

- (1) Preside at all meetings of the ADA Advisory Committee.
- (2) Serve as spokesperson for the ADA Advisory Committee.
- (3) Appoint special committees as deemed necessary and appropriate.
- (4) Prepares the agenda for each meeting.
- (5) Attend or designate a board member to represent the Board at all functions deemed pertinent to the ADA Advisory Committee.

B. Vice Chairman

- (1) Will assume the duties of the chairman in his absence.
- (2) Will chair all special committees.

Article V. Meetings

The ADA Advisory Board shall meet quarterly in the months of January, April, July, and October at three thirty p.m. (3:30 p.m.). These meetings shall be open to the public. Special meetings may be called by the chairman to conduct ADA Advisory Committee business as deemed necessary. All meetings shall be conducted by the Robert Rules of Order.

Article VI. Quorum and Voting

A quorum for the transaction of business shall exist whenever a majority of the Committee Members is present. Any proposal to come before the Committee shall be deemed to be adopted or rejected upon the affirmative vote of the majority of the members present, provided a quorum is present.

Article VII. Executive Session

The Committee shall have the right, with the majority vote, to go into Executive Session concerning official matters.

Article VIII. Liability

The Committee nor any of its Members shall be held liable for the advice that they give the St. Bernard Parish Council and/or St. Bernard Parish Administration for any official acts by this Administration.

Article IX. Nominations of Officers

The nomination and election for new officers shall be taken in January every other year (year 1 of new board members and year 3), at the regular scheduled January meeting. These motions should be placed under the General Order Section of the Board's Agenda.
