AN ORDINANCE TO AUTHORIZE THE RETENTION OF GUICE A. GIAMBONE, III OF BLUE WILLIAMS, L.L.P., TO PROVIDE LEGAL REPRESENTATION FOR ST. BERNARD PARISH GOVERNMENT AND THE ARCHDIOCESE OF NEW ORLEANS IN THE CASE OF MELISSA BLUNT V. ST. BERNARD RECREATION DEPARTMENT IN C.D.C. NO. 19-12254.

WHEREAS, St. Bernard Parish Government believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to retain Guice A. Giambone, III of Blue Williams, L.L.P. to represent their interests in the above matter; and,

WHEREAS, St. Bernard Parish Government must provide legal representation to the Archdiocese of New Orleans, pursuant to an indemnity agreement.

### ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council, the Governing Authority, does hereby approve and authorize the hiring of private counsel to represent St. Bernard Parish Government and the Archdiocese of New Orleans, pursuant to an indemnity agreement, solely in the case Melissa Blunt v. St. Bernard Recreation Department in C.D.C. No. 19-12254 and any matters related thereto.

**SECTION 2.** Compensation. The compensation shall be pursuant to the retention letter attached as Exhibit A.

**SECTION 3.** Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.




