AN ORDINANCE TO AUTHORIZE THE RETENTION OF GREGORY NOTO OF NOTO LAW FIRM, LLC TO PROVIDE LEGAL REPRESENTATION FOR ST. BERNARD PARISH GOVERNMENT IN CONNECTION WITH CASE # 19-1769 DAVID C. JARRELL V. ZOMO, LLC.

WHEREAS, the St. Bernard District Attorney's Office cannot represent St. Bernard Parish Government in this particular matter, as the Plaintiff is an Assistant District Attorney; and,

WHEREAS, St. Bernard Parish Government believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to retain Gregory Noto to represent their interests in the above matters.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council, the Governing Authority, does hereby approve and authorize the hiring of private counsel, Gregory Noto, to represent St. Bernard Parish Government solely in the matter of Case # 19-1769 David C. Jarrell v. ZoMo LLC, filed in the 34th Judicial District Court, and any matters related thereto.

SECTION 2. Compensation. The compensation shall be pursuant to the contract attached as **Exhibit A**.

SECTION 3. Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 5. The Parish President is hereby authorized to enter into a contract for legal services as provided in the attached contract and in accordance with section 4-02 (b) of the Home Rule Charter.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:







\$40.00	PER HOUR FOR LAW CLERK SERVICES


