BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, MARCH 3, 2020 AT SEVEN O'CLOCK P.M.

On motion of Mrs. Alcon, seconded by Mr. Lewis, it was moved to **adopt** the following ordinance:

AN ORDINANCE TO DECLARE AS SURPLUS 2200 KENNETH DR, WHICH IS OWNED BY THE PARISH, AND TO AUTHORIZE THE SALE OF SAID PROPERTY AT PUBLIC AUCTION ACCORDING TO LAW.

WHEREAS, the property located at 2200 KENNETH DR was a former Road Home property that was conveyed to St. Bernard Parish Government; and,

WHEREAS, the Parish considers this property surplus and it is not needed for a public purpose.

ST. BERNARD PARISH COUNCIL, THE GOVERNING AUTHORITY, DOES HEREBY ORDAIN:

SECTION 1. The following property is surplus and is not needed for any public purpose:

2200 KENNETH DR
LOT 70 FRANCKE TRACT SUB. 62 X 81 = 5022

This property will be referred to hereinafter in this ordinance as "2200 Kenneth Dr".

SECTION 2. 2200 Kenneth Dr. shall be sold in accordance with law to the highest bidder at an auction conducted by St. Bernard Parish Government, without warranty of title, all closing costs to be paid by the highest bidder. The minimum accepted bid shall be the appraised value.

SECTION 3. Any objection to the sale of 2200 Kenneth Dr. must be filed with the Clerk of the Council within fifteen (15) days of the posting or the publication of this ordinance.

SECTION 4. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 5. The Parish President and the Chief Administrative Officer each is hereby authorized to execute all instruments necessary to effectuate the conveyances authorized by this ordinance. It is recognized and agreed the Parish President and/or Chief Administrative Officer may nominate a designee by use of a power of attorney to sell the property in accordance with the laws of Louisiana.

SECTION 6. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

SECTION 7. Other Ordinances and Codes Unaffected. Nothing herein shall be interpreted to repeal or otherwise diminish the powers of the Parish or its employees, officers, or agents under any other ordinance or code, including but not limited the Zoning Ordinance, the Building Code, and the Minimum Housing Code, all of which shall apply to the property in addition to the provisions of this ordinance.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




