AN ORDINANCE TO RENAME MARIETTA PARK TO RANDY CARRERAS, JR. MEMORIAL PARK.

**WHEREAS**, Randy Carreras, Jr. was a life-long resident of St. Bernard Parish who personally maintained the Marietta Park for many years at his own expense for the benefit of the citizens of St. Bernard Parish; and,

**WHEREAS**, Concerned Citizens have expressed interest in renaming Marietta Park to Randy Carreras, Jr. Park in memory of Randy Carreras, Jr.; and,

**WHEREAS**, the Council is desirous of honoring this request by renaming Marietta Park to Randy Carreras Jr. Memorial park; and,

**WHEREAS**, the Council is requesting that Administration notify the local U.S. Postal Service and the 911 Communication Center of this change.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** That St. Bernard Parish Council, the Governing Authority, does hereby approve the official renaming of Marietta Park to Randy Carreras, Jr. Memorial Park.

**SECTION 2.** That the Parish President notify the local U.S. Postal Service and the 911 Communication Center of this change.

**SECTION 3.** Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.


