AN ORDINANCE TO RENAME MARIETTA PARK TO RANDY CARRERAS, JR. MEMORIAL PARK.

WHEREAS, Randy Carreras, Jr. was a life-long resident of St. Bernard Parish who personally maintained the Marietta Park for many years at his own expense for the benefit of the citizens of St. Bernard Parish; and,

WHEREAS, Concerned Citizens have expressed interest in renaming Marietta Park to Randy Carreras, Jr. Park in memory of Randy Carreras, Jr.; and,

WHEREAS, the Council is desirous of honoring this request by renaming Marietta Park to Randy Carreras Jr. Memorial park; and,

WHEREAS, the Council is requesting that Administration notify the local U.S. Postal Service and the 911 Communication Center of this change.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That St. Bernard Parish Council, the Governing Authority, does hereby approve the official renaming of Marietta Park to Randy Carreras, Jr. Memorial Park.

SECTION 2. That the Parish President notify the local U.S. Postal Service and the 911 Communication Center of this change.

SECTION 3. Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.


