## RESOLUTION SBPC #2086-12-20

A RESOLUTION APPROVING THE PLACEMENT OF A FOUR WAY STOP SIGN AT THE INTERSECTION OF JUDY DRIVE AND TRACY STREET, MERAUX, LA.

WHEREAS, St. Bernard Parish Council adopted Ordinance SBPC #2240-06-20 at the June 2, 2020 Council Meeting; and,

WHEREAS, Ordinance SBPC #2240-06-20 states stop signs cannot be added or removed without a letter of recommendation from the Director of Public Works and a resolution approval from the Parish Council; and,


