On motion of Mr. Everhardt, seconded by Ms. Callais, it was moved to adopt the following resolution:

RESOLUTION SBPC #2103-02-21

A RESOLUTION RESPECTFULLY REQUESTING THAT THE COASTAL PROTECTION AND RESTORATION AUTHORITY "CPRA" PROVIDE AMPLE NOTICE TO ST. BERNARD PARISH GOVERNMENT PRIOR TO OPENING OR ADJUSTING THE CAERNARVON FRESHWATER DIVERSION.

WHEREAS, St. Bernard Parish Fishermen have equipment (such as crab traps) in the surrounding bayous and lakes that are connected to the Diversion Outfall Canal that can be lost due to the increased amount of Cubic Feet per Second "CFS"; and,

WHEREAS, each time the diversion is opened it creates a negative economic impact on the wetlands, commercial fishing industry, recreational fishing and hunting and the Quality of Life and Safety of the residents of St. Bernard Parish; and,

WHEREAS, St. Bernard Parish President, Guy McInnis, is in full support of this resolution.

NOW THEREFORE BE IT RESOLVED that the St. Bernard Parish Council, the governing authority, does hereby respectfully request that the Coastal Protection and Restoration Authority "CPRA" provide ample notice to St. Bernard Parish Government prior to opening or adjusting the Caernarvon Freshwater Diversion.


