AN ORDINANCE TO APPROVE DOCKET Z-2021-001, PETITION OF ROBERT DUCOTE. FOR A ZONING CHANGE FROM C1 (NEIGHBORHOOD COMMERCIAL) TO C1 WITH A CONDITIONAL USE TO CONSTRUCT A NEW WAREHOUSE. PROPERTY LOCATION: 2520 LIVACCARI DR. VIOLET, LA 70092.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council does hereby approve **Docket Z-2021-001**, petition of Robert Ducote for a zoning change from C1 (Neighborhood Commercial) to C1 w/conditional use to construct a new warehouse with the following conditions.

Conditions:

- Applicant must adhere to the recommendations of the staff which includes perimeter fencing, parking spaces, the landscaping plan as submitted and to follow all other applicable code laws.

Property Location: 2520 Livaccari Dr. Violet, LA 70092

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause,
