AN ORDINANCE TO DECLARE CLASSIFICATION OF EMPLOYEE UNDER ST. BERNARD PARISH'S PERSONNEL SYSTEM.

WHEREAS, Section 4-10(b) of St. Bernard Parish's Home Rule Charter provides that employees named directly by the St. Bernard Parish Council shall not be members of the classified personnel system of St. Bernard Parish;

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council, pursuant to Section 4-10(b) of St. Bernard Parish's Home Rule Charter, does hereby name Merritt Landy, in his current position, as unclassified personnel.

SECTION 2. Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.

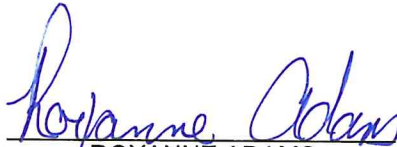

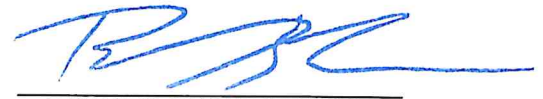

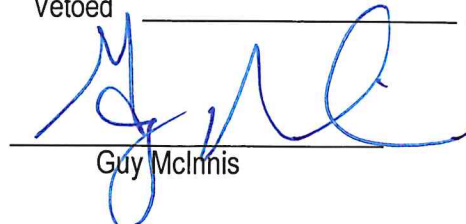
