AN ORDINANCE TO DECLARE CERTAIN PARISH OWNED PROPERTIES AS SURPLUS AND TO AUTHORIZE THE EXCHANGE OF SAME FOR PROPERTY OWNED BY STEVE LOMBARDO, JR.

ST. BERNARD PARISH COUNCIL, THE GOVERNING AUTHORITY, DOES HEREBY FIND IT NECESSARY AND IN THE PUBLIC INTEREST TO ORDAIN:

WHEREAS, St. Bernard Parish desires to exchange certain parish-owned properties for a certain property owned by Steve Lombardo, Jr. which is more advantageously located with respect to conducting interior drainage operations within St. Bernard Parish; and

WHEREAS, whereas the properties sought to be exchanged by St. Bernard Parish are surplus and not needed for any public purpose.

**SECTION 1.** The following property is surplus and is not needed for any public purpose:

### Property No. 1:

A CERTAIN PIECE OR PORTION OF GROUND, together with all the rights, ways, privileges, servitudes, advantages and appurtenances thereunto belonging or in anywise appertaining, situated in Arabi, PARISH OF ST. BERNARD, STATE OF LOUISIANA, in that portion thereof known as CAROLYN PARK SUBDIVISION, and in accordance with survey made by F.C. ONE (1) CERTAIN PORTION OF GROUND, together with all the buildings and improvements thereon and all the rights, ways, privileges, servitudes, appurtenances and advantages thereunto belonging or in anywise appertaining, situated in the Parish of St. Bernard, State of Louisiana, in Dauterive Subdivision, in that area bounded by Dauterive Drive, Peoples Street, western boundary of subdivision and drainage canal, designated as Lot 45, according to survey of Eugene I. Estopinal, C.E., dated September 27, 1974, annexed to vendor's act of sale, and which said Lot 45 commences at the intersection of Dauterive Drive with the drainage canal, and measures thence 90.80 feet front on Dauterive Drive, a width in the rear of 76.84 feet, by a depth on the Peoples Street side of 70 feet, and a depth along the drainage canal of 71.38 feet, subject to a 10 foot easement along said drainage canal; being that same property conveyed in the Non-Warranty Cash Sale recorded in the conveyance records of St. Bernard Parish at Book 1121, Page 853.

In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 5.** The Parish President and the Chief Administrative Officer each is hereby authorized to execute all instruments necessary to effectuate the conveyances authorized by this ordinance. It is recognized and agreed the Parish

President and/or Chief Administrative Officer may nominate a designee by use of a power of attorney to exchange the properties in accordance with the laws of Louisiana.

**SECTION 6.** Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

**SECTION 7.** Other Ordinances and Codes Unaffected. Nothing herein shall be interpreted to repeal or otherwise diminish the powers of the Parish or its employees, officers, or agents under any other ordinance or code, including but not limited the Zoning Ordinance, the Building Code, and the Minimum Housing Code, all of which shall apply to the property in addition to the provisions of this ordinance.
