A RESOLUTION AUTHORIZING A GRANT APPLICATION TO THE LOUISIANA DIVISION OF THE ARTS (LDOA) IN THE AMOUNT OF \$5,000.00 FOR THE WIND-DOWN WEDNESDAYS CONCERT SERIES IN TORRES PARK.

WHEREAS, the Louisiana Division of the Arts, funds the Decentralized Arts Funding Program makes arts available in every parish in the State of Louisiana by grant funding, based on U.S. Census figures, for nonprofits organizations, community groups, and local governmental agencies producing cultural programs; and,

WHEREAS, the State of Louisiana has established an agreement with the St. Tammany Commission on Cultural Affairs to administer this program for the Parishes of St. Tammany and St. Bernard; and,

WHEREAS, the Decentralized Arts Funding Program has issued a call for the FY22 Grant Applications; and,

WHEREAS, St. Bernard Parish is eligible to apply for this grant program which requires a 50% local match to granted funds; and,

WHEREAS, St. Bernard Parish is interested in expanding opportunities for residents to enjoy all types of music and the opportunity to shop local with local food and craft vendors.

NOW THEREFORE BE IT RESOLVED that the St. Bernard Parish Council, does hereby authorize the submission of a grant application to the Louisiana Division of the Arts as administered by St. Tammany Parish Commission on Cultural Affairs, in the amount of Five Thousand Dollars (\$5,000.00) in order to host the Wind-Down Wednesday Concert Series in Torres Park; and,
