On motion of Mr. McCloskey, seconded by Ms. Callais, it was moved to adopt the following resolution:

RESOLUTION SBPC #2166-08-21

A RESOLUTION AUTHORIZING AN APPLICATION AMENDMENT TO THE LOUISIANA OFFICE OF COMMUNITY DEVELOPMENT (CDBG) TO INCREASE THE AMOUNT OF COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM INCOME FUNDS FOR THE ST. BERNARD PARISH PARK REDEVELOPMENT PLAN FROM \$2,000,000 to \$3,500,000.

WHEREAS, there are existing parks and public use lots in St. Bernard Parish with unmet needs; and,

WHEREAS, the Parish's Comprehensive Plan promotes redevelopment of parks throughout St. Bernard Parish; and,

WHEREAS, St. Bernard Parish has previously authorized \$2,000,000 for the proposed ST. BERNARD PARISH PARK REDEVELOPMENT PLAN.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, does hereby authorize the submission of an application amendment to the State of Louisiana Office of Community Development for the ST. BERNARD PARISH PARK REDEVELOPMENT PLAN for an increase in the amount of \$1,500,000, for a total CDBG budget of \$3,500,000; and,

BE IT FURTHER RESOLVED, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required application documents and agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with this Louisiana Office of Community Development Block Grant Program.


