## **RESOLUTION SBPC #2179-10-21**

A RESOLUTION AUTHORIZING AN APPLICATION FOR EDA AMERICAN RESCUE PLAN ECONOMIC ADJUSTMENT ASSISTANCE PROGRAM AND CONFIRMING NON-EDA MATCH REQUIREMENTS FUNDING AVAILABILITY.

**WHEREAS**, the government of the United States of America has enacted The American Rescue Plan Act (ARPA) providing the Economic Development Administration (EDA) with \$500 million for economic development assistance programs to help communities prevent, prepare for, and respond to coronavirus; and

**WHEREAS**, the EDA American Rescue Plan Act Recovery Assistance, which is being administered under the authority of the flexible Economic Adjustment Assistance (EAA) program (the "Program"), provides a wide-range of financial assistance to communities and regions as they respond to and recover from the impacts of the pandemic; and

**WHEREAS**, the St. Bernard Parish Government (the "Parish") has been negatively impacted as a result of the coronavirus pandemic and is eligible to apply for assistance under the Program; and

**WHEREAS**, the Parish intends to utilize in-kind funds realized through the Program to assist in the St. Bernard North-South Intermodal Connector Road Project for the development, construction, and operation of new connector road in St. Bernard Parish, Louisiana (the "Project").

**NOW THEREFORE, BE IT RESOLVED** and ordered that Guy McInnis, the Parish President of St. Bernard Parish, is authorized and designated as the Parish representative to apply for, accept, decline, modify, or cancel the contemplated application for EDA American Rescue Plan Act Economic Adjustment Assistance in connection with the Project, and is further authorized to execute all documents necessary to apply for and accept any funds received through the Program on behalf of the Parish; and
