## **RESOLUTION SBPC #2181-11-21**

A RESOLUTION AUTHORIZING AND APPROVING THE ADDITION OF THE PATRICIA STREET AT CHALMETTE VISTA CANAL STRUCTURE NO. 024429574895831 TO THE 2021 – 2023 PRIORITY LIST FOR REPLACEMENT UNDER THE FEDERAL OFF-SYSTEM BRIDGE REHABILITATION AND REPLACEMENT PROGRAM.

**WHEREAS**, on October 5, 2021, St. Bernard Parish adopted Resolution No. SBPC 2174-10-21 to participate in the Federal Off-System Bridge Rehabilitation and Replacement Program, which is administered by the Louisiana Department of Transportation and Development (LADOTD); and,

**WHEREAS**, the LADOTD and the Federal Highway Administration (FHWA) have now appropriated funds for the Off-System Program for the 2021 - 2023 federal fiscal years; and,

**WHEREAS**, the Department of Public Works was asked to select from this list those bridges that are to be placed on the 2021 – 2023 Priority List; and,

**WHEREAS**, after reviewing the 2021-2023 priority list with a single structure listed the Patricia Street at Chalmette Vista Canal Structure No. 024429574895831 was selected as the best candidate for replacement; and,

**WHEREAS**, the estimated cost figured by the Engineering Department for the replacement of this bridge is \$750,000.00.

**NOW, THEREFORE, BE IT RESOLVED** by the St. Bernard Parish Council, the governing authority does hereby authorize and approve Patricia Street at Chalmette Vista Canal Structure No. 024429574895831 to the 2021 – 2023 Priority List for replacement under the Federal Off-System Bridge Rehabilitation and Replacement Program


The Council Chair, Mr. Lewis, cast his vote as **YEA**.
