## **ORDINANCE SBPC #2462-11-22**

### **Summary No. 4053**

AN ORDINANCE TO **AMEND** CHAPTER 2, ADMINISTRATION; ARTICLE I, IN GENERAL; SECTION 2-4, PARISH COUNCIL MEMBERS' SALARIES OF THE ST. BERNARD PARISH CODE OF ORDINANCES.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council does hereby amend Chapter 2, Article I, Section 2-4; Council Member's Salary to read as follows:

**Sec. 2-4.** Parish council members' salaries.

(a) The salary of the parish council effective at the beginning of the 2016 term of office shall be as follows:

- (1) The district council members shall receive a salary of one thousand two hundred fifty dollars (\$1,250.00) per month.
- (2) The at-large members shall receive a salary of one thousand four hundred fifty dollars (\$1,450.00) per month.
- (3) The chairman shall receive a salary of one thousand six hundred fifty dollars (\$1,650.00) per month.

(b) The salary of the parish council effective at the beginning of the 2024 term of office shall include a two- percent (2%) raise for inflation each year thereafter.

**SECTION 2.** Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.


