RESOLUTION SBPC #2251-08-22

A RESOLUTION RESPECTFULLY REQUESTING THAT ENTERGY DEVELOP AND IMPLEMENT A PROGRAM TO DELAY THE DISCONNECTION OF SERVICES TO PARISH RESIDENTS STRUGGLING TO AFFORD THEIR ELECTRIC BILL DURING THIS PERIOD OF EXTREME TEMPERATURE AND HIGH COST.

WHEREAS, the high electric bills that are the result of extreme temperatures and elevated fuel prices are hitting unaffordable levels with our residents; and,

WHEREAS, the impact that the high bills are having on our vulnerable population and elderly on fixed incomes who cannot be left in these dangerous temperatures without power; and,

WHEREAS, the governing authority is concerned about the health, safety and welfare of our residents during this time as a result of the weather and higher cost of electricity.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council, the governing authority, does hereby respectfully request that Entergy develop and implement a program to delay the disconnection of services to parish residents struggling to afford their electric bill during this period of extreme temperature and high cost.
