## **RESOLUTION SBPC #2254-08-22**

A RESOLUTION APPROVING THE PLACEMENT OF A THREE WAY STOP SIGN AT THE CORNER OF CREOLE DRIVE AND EVANGELINE AVENUE, CHALMETTE, LA.

**WHEREAS**, St. Bernard Parish Council adopted Ordinance SBPC #2240-06-20 at the June 2, 2020 Council Meeting; and,

**WHEREAS**, Ordinance SBPC #2240-06-20 states stop signs cannot be added or removed without a letter of recommendation from the Director of Public Works and a resolution approval from the Parish Council; and,

**WHEREAS**, attached is a letter of recommendation from the Director of Public Works.

**NOW THEREFORE, BE IT RESOLVED**, that the St. Bernard Parish Council, the governing authority, does hereby approve the placement of a three way stop sign at the corner of Creole Drive and Evangeline Avenue, Chalmette, La.


