A RESOLUTION APPROVING THE PLACEMENT OF A THREE WAY STOP SIGN AT THE CORNER OF FARMSITE ROAD AND WOODCHASE COURT, VIOLET, LA.

WHEREAS, St. Bernard Parish Council adopted Ordinance SBPC #2240-06-20 at the June 2, 2020 Council Meeting; and,

WHEREAS, Ordinance SBPC #2240-06-20 states stop signs cannot be added or removed without a letter of recommendation from the Director of Public Works and a resolution approval from the Parish Council; and,

WHEREAS, attached is a letter of recommendation from the Director of Public Works.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, does hereby approve the placement of a three way stop sign at the corner of Farmsite Road and Woodchase Court, Violet, La.





As requested by Council Member District E, Fred Everhardt, Jr., I am recommending a three way stop sign at the following location:
