BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY OCTOBER 4, 2022 AT SEVEN O'CLOCK P.M.

On motion of Mrs. Alcon, seconded by Mr. Moran, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2266-10-22

A RESOLUTION AUTHORIZING AN APPLICATION AMENDMENT TO THE LOUISIANA OFFICE OF COMMUNITY DEVELOPMENT (CDBG) TO INCREASE THE AMOUNT OF COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM INCOME FUNDS FOR THE ST. BERNARD PARISH PARK REDEVELOPMENT PLAN FROM \$3,500,000 to \$5,000,000.

WHEREAS, there are existing parks and public use lots in St. Bernard Parish with unmet needs; and,

WHEREAS, the Parish's Comprehensive Plan promotes redevelopment of parks throughout St. Bernard Parish; and,

WHEREAS, St. Bernard Parish has previously authorized resolution SBPC #2077-10-20 committing \$2,000,000 of CDBG-DR Program Income funding for the proposed ST. BERNARD PARISH PARK REDEVELOPMENT PLAN; and,

WHEREAS, St. Bernard Parish has previously authorized resolution SBPC #2166-08-21 committing \$1,500,000 of CDBG-DR Program Income funding for the proposed ST. BERNARD PARISH PARK REDEVELOPMENT PLAN for a total CDBG-DR Program Income budget of \$3,500,000.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, does hereby authorize the submission of an application amendment to the State of Louisiana Office of Community Development for the ST. BERNARD PARISH PARK REDEVELOPMENT PLAN for an increase of CDBG-DR Program Income funding in the amount of \$1,500,000, for a total CDBG-DR budget of \$5,000,000; and,

BE IT FURTHER RESOLVED, the St. Bernard Parish Council, does hereby authorize the President of St. Bernard Parish Government to sign and execute all required application documents and agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with this Louisiana Office of Community Development Block Grant Program.
