A RESOLUTION AUTHORIZING A GRANT APPLICATION TO THE STATE OF LOUISIANA OFFICE OF COMMUNITY DEVELOPMENT, LOCAL GOVERNMENT ASSISTANCE PROGRAM FOR FY2022-2023 IN THE AMOUNT OF \$180,000.00 FOR THE PURCHASE OF NEW PUBLIC WORK VEHICLES.

WHEREAS, the FY 2022-23 State of Louisiana Office of Community Development, Local Government Assistance Program (LGAP) is a State of Louisiana program designed to provide financial assistance to local units of government in rural areas; and

WHEREAS, St. Bernard Parish is seeking grant funding to provide three F-250 (or similar) 4X4, heavy duty trucks to pull equipment from job site to job site and one F-150 (or similar) for employee to inspect sites, drains, etc. throughout the entire St. Bernard Parish on a daily basis; and

NOW THEREFORE BE IT RESOLVED that the St. Bernard Parish Council, does hereby authorize the submission of a FY 2022-23 grant application to the State of Louisiana Office of Community Development, Local Government Assistance Program (LGAP) in the amount of \$180,000.00 for the Public Works vehicles; and

BE IT FURTHER RESOLVED that the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to sign and submit all required grant applications, Cooperative Endeavor Agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with the State of Louisiana Office of Community Development, Local Government Assistance Program (LGAP); and
