On motion of Mr. McCloskey, seconded by Mrs. Alcon, it was moved to **adopt** the following resolution:

## RESOLUTION SBPC #2273-11-22

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO COMPLETE AND SUBMIT THOSE DOCUMENTS AND AGREEMENTS REQUIRED IN CONNECTION WITH THE COMMUNITY WATER ENRICHMENT FUND (CWEF) 2022-2023 GRANT APPLICATION IN THE SUM OF \$170,000.00 TO THE STATE OF LOUISIANA TO INSTALL A NEW HIGH SERVICE WATER DISTRIBUTION PUMP.

**WHEREAS**, the Public Works Department is responsible to provide maintenance and repairs on the water and sewer system in St Bernard Parish; and,

**WHEREAS**, there is a need for the Public Works Department for the installation of a new 7,000 Gallon Per Minute (GPM) high service water distribution pump with Variable Frequency Drive (VFD) motor, ductile iron piping, valves, backflow preventers, electrical controls, and magnetic flow meters; and,

**WHEREAS**, the purpose of CWEF is to assist local governments with grant funding, with no match or reimbursement required from the recipient or Parish, for rehabilitation, improvement, and construction projects on community water systems for eligible Parishes in the amount of \$170,000.00; and,

**WHEREAS**, the grant will allow the Parish to use the grant in the amount of \$170,000.00 to install this new high service pump will replace an existing high service pump, which has currently surpassed its design life, and is unreliable, deteriorating, and beyond repair.

**NOW, THEREFORE, BE IT RESOLVED** by the St. Bernard Parish Council, acting as governing authority of said Parish

**SECTION 1.** That the St. Bernard Parish Council does hereby authorize the Parish President to complete and submit those documents and agreements required in connection with the Community Water Enrichment Fund (CWEF) 2022-2023 grant application totaling \$170,000.00 to the State of Louisiana to assist the Public Works Department with the installation of isolation valves in various locations throughout the water distribution system.


