EXTRACT OF THE OFFICIAL PROCEEDINGS OF THE COUNCIL OF THE PARISH OF ST. BERNARD, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING HELD IN THE COUNCIL CHAMBERS OF THE ST. BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY NOVEMBER 15, 2022 AT THREE O'CLOCK P.M.

On motion of Mr. Lewis, seconded by Mr. Moran, it was moved to **adopt** the following resolution:

## **RESOLUTION SBPC #2277-11-22**

A RESOLUTION REQUESTING A COMMITMENT FROM THE PORT OF NEW ORLEANS, GOVERNOR JOHN BEL EDWARDS, ALL LOUISIANA LEGISLATORS, REGIONAL PLANNING COMMISSION, AND THE FEDERAL DELGATIONS THAT NO CONSTRUCTION WILL BEGIN ON THE ANTICIPATED LOUISIANA INTERNATIONAL TERMINAL (LIT) PROJECT IN VIOLET, LOUISIANA UNTIL SUCH TIME AS COMPLETE FUNDING HAS BEEN OBTAINED AND THE PROJECT IS FULLY PERMITTED FOR CONSTRUCTION OF A NORTH-SOUTH CORRIDOR DIRECTLY CONNECTED TO THE LIT PROJECT TO MINIMIZE IMPACT ON THE EXISTING INFRASTRUCTURE IN ST. BERNARD PARISH.

**WHEREAS**, the Port of New Orleans is in the process of developing that certain project referenced as the Louisiana International Terminal (LIT) project in Violet, LA which shall consist, in part, of a shipping container yard LIT; and,

**WHEREAS**, the anticipated location of the LIT project is wholly within St. Bernard Parish; and,

**WHEREAS**, based upon the information provided to date by the Port of New Orleans to St. Bernard Parish Government, it appears that activity associated with the LIT project will overwhelm St. Bernard Parish's infrastructure as it currently exists, including by not limited to the anticipated increased vehicular traffic on the roadways within St. Bernard Parish; and,

**WHEREAS**, it is anticipated that St. Bernard Parish's existing infrastructure will begin experiencing a negative impact from the LIT project when construction of same begins.

**NOW THEREFORE, BE IT RESOLVED**, that in an effort to preserve the infrastructure of St. Bernard Parish and as a demonstration of good will towards the residents of St. Bernard Parish, the St. Bernard Parish Council does hereby seek and request a commitment from the CEO and the Board of Directors of the Port of New Orleans that construction on the LIT project shall not begin until such time as complete funding has been obtained and the project is fully permitted for the construction of a North-South Corridor which would allow for the diversion of traffic


The Council Chair, Ms. Callais, cast her vote as **YEA**.
