## RESOLUTION SBPC #2290-03-23

A RESOLUTION RESPECTFULLY REQUESTING THAT THE LOUISIANA DEPARTMENT OF TRANSPORTATION OR THE ST. BERNARD PARISH GOVERNMENT REMOVE DISCARDED TIRES LOCATED ON PARIS ROAD.

**WHEREAS**, the existence of abandoned tires on Paris Road violate local ordinances and state laws; and,

**WHEREAS**, the presence of the abandoned tires represent a threat to the health and safety of our residents by provides a breeding ground for mosquitos; and,

**WHEREAS**, the beautification of Paris Rd. is important for attracting new residents and businesses to St. Bernard Parish.

**NOW THEREFORE, BE IT RESOLVED**, that the Parish Council, the governing authority, hereby request that the Louisiana Department of Transportation or the St. Bernard Parish Government remove the discarded tires on Paris Road.
