## **ORDINANCE SBPC #2484-04-23**

AN ORDINANCE TO **AMEND** ORDINANCE SBPC #1993-08-17, AN ORDINANCE ESTABLISH A SPECIAL REVENUE FUND "TREE FUND" AND IMPLEMENT STIPULATIONS FOR ALL REVENUES AND EXPENDITURES IN THE ST. BERNARD PARISH ANNUAL OPERATING AND CAPITAL BUDGET.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** the St. Bernard Parish Council, does hereby amend SBPC #1993-08-17, an ordinance to establish a Special Revenue Fund "Tree Fund" and implement stipulations for all revenues and expenditures in the St. Bernard Parish Annual Operating and Capital Budget.

**WHEREAS**, the St. Bernard Council, Governing Authority of St. Bernard Parish, does hereby establish a special revenue fund and implemented stipulations for all revenues and expenditures for said fund; and,

**WHEREAS**, the special revenue fund referred to as the Tree Fund will be established as Fund 234, and;

**WHEREAS**, the revenues for said fund shall come from any and all permit fees involving tree cutting and/or trimming as well as any fines incurred for the trimming and/or cutting of trees without a permit, and;

**WHEREAS**, any expenditures for said fund shall go before the full Council for approval before any expenses are paid, and;

**WHEREAS**, the expenditures from this fund shall only be for the purpose of planting new trees or for the beautification of St. Bernard Parish as recommended by approval by the Council.

**SECTION 2. Effective Date.** This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 3. Severability.** If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


