BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, APRIL 18, 2023 AT THREE O'CLOCK P.M.

On motion of Mr. Luna, seconded by Mr. McCloskey, it was moved to **adopt** the following Ordinance:

AN ORDINANCE TO ESTABLISH A SPECIAL REVENUE FUND "RIDE SHARE FEES" AND IMPLEMENT STIPULATIONS FOR REVENUES AND EXPENDITURES IN THE ST. BERNARD PARISH ANNUAL OPERATING AND CAPITAL BUDGET.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Council, Governing Authority of St. Bernard Parish, does hereby establish a special revenue fund and implement stipulations for revenues and expenditures on for said fund.

WHEREAS, the special revenue fund referred to as the Ride Share Fee will be established as Fund 237, and;

WHEREAS, the revenues for said fund shall come from ride share fees collected from UBER and Lyft, and;

WHEREAS, any expenditures directly associated with the installation, repair, and maintenance of sidewalks for said fund shall go before the full Council for final approval before any expenses are paid, and;

WHEREAS, the expenditures from this fund shall only be for the purpose of installation, repair, and maintenance of sidewalks in St. Bernard Parish by final approval by the Council.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




