H.014399 (331) UNDER THE STATEWIDE FLOOD CONTROL PROGRAM WERE RECEIVED IN ACCORDANCE WITH AND COMPLY WITH THE CURRENT BID LAWS OF THE STATE OF LOUISIANA, INCLUDING, BUT NOT LIMITED TO R.S. 38:2211 ET SEQ.


The Council Chair, Mr. Lewis, cast his vote as **YEA**.
