A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO AWARD A CONTRACT TO THE LOWEST RESPONSIVE AND QUALIFIED BIDDER, LMB SERVICES, LLC. FOR BUCCANEER VILLA NORTH SUBDIVISION PHASE 1 – RETENTION POND STATE PROJECT NO. H.014399 (331) UNDER THE STATEWIDE FLOOD CONTROL PROGRAM WITH THE PURPOSE OF REDUCING FLOODING IN THE ST. CLAUDE HEIGHTS, CAROLYN PARK, BUCCANEER VILLA NORTH, AND CHALMETTE PLAZA SUBDIVISIONS.

WHEREAS, St. Bernard Parish has received bids on January 17, 2023 on the State Project No. H.014399 (331) Buccaneer Villa North Subdivision Phase 1 – Retention Pond project under the Statewide Flood Control Program; and

WHEREAS, Digital Engineering & Imaging, Inc. has recommended that award of contract be made to the lowest responsive and qualified bidder; LMB Services, LLC.

NOW, THEREFORE, BE IT RESOLVED, by the St. Bernard Parish Council, in Regular session assembled on this 4<sup>th</sup> Day of April 2023, acting pursuant to the recommendation of Digital Engineering & Imaging, Inc. that the Base Bid in the Amount of \$3,591,918.60 by LMB Services, LLC. be accepted and that Guy McInnis, Parish President is hereby authorized to award a contract to LMB Services, LLC.
