

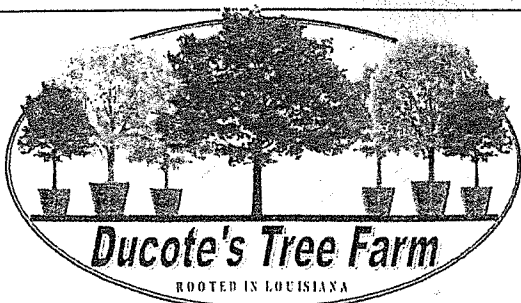

Scope of Work: Twin Shores will provide services to PLANT 25 Live Oak Trees and install Tree staking, Mulch and Watering Bags within the following described areas: Judge Perez Dr. (Village Square) Tree Planting Streetscape from DeLaRonde Dr. to 9109 W. Judge Perez Dr. Corridor, Work to be performed will take place in hard service area along highway ROW.

TREE PLANTING:

- a. 25 Live Oaks 3" caliper, 10-12' in height with 65 -gallon container ball will be planted.
- b. Trees are to be planted with fifty (50') spacing and eight (8) feet from curb.
- c. All plantings will require up to a 14' x 14' concrete saw cut. **Saw cuts to be done by SBPG.**
- d. All tree beds shall be completed by placing pine straw mulching to cover the 14 x 14 area.
- e. All trees shall be braced and tied with T-post supports to provide support from wind until tree is established. T-post to be removed by vendor upon owners (SBPG) request.

Maintenance:

- a. Watering by SBPG as needed.

Warranty:

- a. Excluded if SBPG is responsible for watering and maintenance.
