RESOLUTION SBPC #2305-05-23

A RESOLUTION RESPECTFULLY REQUESTING ADMINISTRATION TO PROVIDE THE ST. BERNARD PARISH COUNCIL WITH A DETAILED AND THOROUGH PLAN TO REPAIR AND/OR REBUILD FIRE STATIONS 11 AND 12 TO A HABITABLE AND FUNCTIONING FIRE STATION.

WHEREAS, St. Bernard Parish Council is desirous to return Fire Stations 11 and 12 to a complete and functioning status; and,

WHEREAS, the residents of Fire District 2 deserve fire protection services that they are currently paying for; and,

WHEREAS, St. Bernard Parish Council is requesting to have this detailed and thorough plan submitted to the Clerk of Council no later than 60 (sixty) days from the date this Resolution is adopted; and,

WHEREAS, once a detailed and thorough plan is received, a proposed budget amendment will be presented; and,

WHEREAS, a detailed plan should be defined as a description and cost estimate of a minimally operational and a maximumly operation plan for both Fire Stations 11 & 12.

NOW, THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council does hereby respectfully request Administration to provide the St. Bernard Parish Council with a detailed and thorough plan to repair and/or rebuild Fire Stations 11 and 12 to a habitable and functioning Fire Station.
