BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, JULY 18, 2023 AT THREE O'CLOCK P.M.

On motion of the Council Chair, without objection and by unanimous consent, it was moved to **remove** the following **Emergency Ordinance**:

EMERGENCY ORDINANCE SBPC #2505-07-23

AN **EMERGENCY ORDINANCE** TO ENSURE THAT ADMINISTRATION CONTINUES TO STAFF, MAINTAIN AND OPERATE FIRE STATIONS 10 & 11 WHILE CONCURRENTLY WORKING ON PRESERVING FIRE STATION 12 TO PREPARE FOR FUTURE USE.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. That this ordinance will ensure that administration will continue to staff, maintain and operate Fire Stations 10 & 11 while concurrently working on preserving Fire Station 12 to prepare for future use.

SECTION 2. That this ordinance will supersede **Ordinance SBPC #2483-04-23** that was adopted on April 18, 2023.

SECTION 3. **Effective Date.** This ordinance shall become effective immediately upon authorizing signature by the Parish President. If the proposed ordinance is not signed or vetoed by the Parish President within Twelve (12) hours after receipt it shall be considered adopted. As an emergency ordinance, the provisions shall remain valid for a time period of sixty (60) days.

SECTION 4. **Severability.** If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion of this Ordinance with the invalid portions omitted.


