EXTRACT OF THE OFFICIAL PROCEEDINGS OF THE COUNCIL OF THE PARISH OF ST. BERNARD, STATE OF LOUISIANA, TAKEN AT A EMERGENCY MEETING HELD IN THE COUNCIL CHAMBERS OF THE ST. BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, AUGUST 29, 2023 AT THREE O'CLOCK P.M.

On motion of Mr. Everhardt, seconded by Mr. Moran, it was moved to **adopt** the following Emergency Ordinance:

## **EMERGENCY ORDINANCE SBPC #2512-08-23**

### **Summary No. 4108**

AN EMERGENCY ORDINANCE **REPEALING EMERGENCY ORDINANCE SBPC #2508-08-23**, WHICH AUTHORIZED THE RETENTION OF BLUE WILLIAMS, L.L.P., TO PROVIDE LEGAL REPRESENTATION FOR ST. BERNARD PARISH GOVERNMENT IN THE CASE OF ST. BERNARD PARISH GOVERNMENT V THE BOARD OF COMMISSIONERS FOR THE PORT OF NEW ORLEANS, 34th JDC 23-1006.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** that **Ordinance SBPC #2508-08-23** authorized the retention of Blue Williams, L.L.P., to provide legal representation for St. Bernard Parish Government in the case of St. Bernard Parish Government v The Board of Commissioners for the Port of New Orleans, 34th JDC 23-1006 is hereby repealed in its entirety.

**WHEREAS**, Blue Williams, L.L.P. was originally retained as Legal Counsel for St. Bernard Parish Government to represent their interests in the above matters;

**WHEREAS**, Blue Williams, L.L.P. officially withdrew as Legal Counsel for St. Bernard Parish Government in the above matters.

**WHEREAS**, St. Bernard Parish Council believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to repeal **Emergency Ordinance SBPC #2508-08-23** in its entirety.

**SECTION 2.** Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. If the proposed ordinance is not signed or vetoed by the Parish President within Twelve (12) hours after receipt it shall be considered adopted. As an emergency ordinance, the provisions shall remain valid for a time period of sixty (60) days.
