EXTRACT OF THE OFFICIAL PROCEEDINGS OF THE COUNCIL OF THE PARISH OF ST. BERNARD, STATE OF LOUISIANA, TAKEN AT AN EMERGENCY MEETING HELD IN THE COUNCIL CHAMBERS OF THE ST. BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, AUGUST 29, 2023 AT THREE O'CLOCK P.M.

On motion of Mr. Moran, seconded by Mr. Everhardt, it was moved to adopt the following emergency ordinance:

EMERGENCY ORDINANCE SBPC #2513-08-23

Summary No. 4109

AN EMERGENCY ORDINANCE TO AUTHORIZE THE RETENTION OF STERNBERG, NACARRI, AND WHITE, LLC. TO PROVIDE LEGAL REPRESENTATION FOR ST. BERNARD PARISH GOVERNMENT IN THE CASE OF ST. BERNARD PARISH GOVERNMENT V THE BOARD OF COMMISSIONERS FOR THE PORT OF NEW ORLEANS, 34th JDC 23-1006.

WHEREAS, St. Bernard Parish Government believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to retain Sternberg, Nacarri, and White, LLC to represent their interests in the above matters.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The St. Bernard Parish Council, the Governing Authority, does hereby approve and authorize the hiring of private counsel, Sternberg, Nacarri, and White LLC., to represent St. Bernard Parish Government in the case of St. Bernard Parish Government v The Board of Commissioners for the Port of New Orleans, 34th JDC 23-1006 and any matters related thereto.

SECTION 2. Compensation. The compensation shall be pursuant to the legal service fee schedule published by the Louisiana Attorney General's office.

SECTION 3. Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. If the proposed ordinance is not signed or vetoed by the Parish President within Twelve (12) hours after receipt it shall be considered adopted. As an emergency ordinance, the provisions shall remain valid for a time period of sixty (60) days.

SECTION 4. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this ordinance. The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:

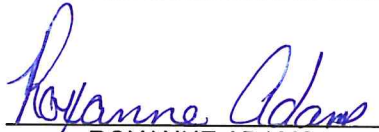

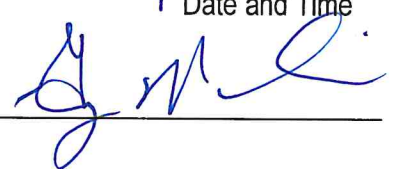

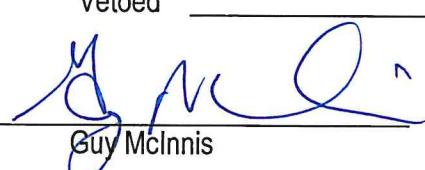
