On motion of Mr. Moran, seconded by Mr. Luna, it was moved to **adopt** the following ordinance:

AN ORDINANCE EMPOWERING THE ST. BERNARD PARISH COUNCIL TO FUND A VILLAGE SQUARE REVITALIZATION DEVELOPMENT.

WHEREAS, the Parish acquired ownership of property in the former Village Square Area with grant funds that require that the property be used as green space; and,

WHEREAS, the Parish Council believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government that all projects be consistent with the green space amenities listed as followed a dog park, a chip and putt course, a soccer field, a softball field, and pickle ball courts. All future projects should be consistent with the public recreational uses listed above at the site of the former Village Square area.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. The Village Square Revitalization Development should be based on the initiatives and vision for public recreation uses presented in the St. Bernard Parish Comprehensive Plan. The green space amenities to be developed at the site must be approved by a majority vote of the St. Bernard Parish Council.

SECTION 2. Any funds private or public collected for the development shall be deposited with the St. Bernard Parish Government Finance Department which funds will be solely used for the development.

SECTION 3. The green space amenities to be developed at the Park must be approved by a majority vote of the Village Square Revitalization Development Committee which consists of the Parish President, or his/her written designee, Council Member, District B or designee, Planning Commission Member, District B or designee, a resident of District B, and the Chairman of the Council or designee. final plans for the Village Square Revitalization Development must be approved by a majority of the Council with a Resolution for each individual green space amenity.

SECTION 4. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 5. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council hereby expresses and declares that it would have adopted the remaining portion this Ordinance with the invalid portions omitted.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
