BERNARD PARISH GOVERNMENT COMPLEX, 8201 WEST JUDGE PEREZ DRIVE, CHALMETTE, LOUISIANA ON TUESDAY, SEPTEMBER 26, 2023 AT TWO O'CLOCK P.M.

On motion of Mrs. Alcon, seconded by Mr. Everhardt, it was moved to **adopt** the following emergency ordinance:

## **EMERGENCY ORDINANCE SBPC #2526-09-23**

### **Summary No. 4122**

AN **EMERGENCY ORDINANCE** TO AMEND **ORDINANCE SBPC #2382-11-21** AUTHORIZING THE ISSUANCE OF TAXABLE HURRICANE RECOVERY BONDS, SERIES 2021, TO PROVIDE FOR THE ADDITIONAL PURPOSE OF EXPENDITURES TO ADDRESS THE SALT WATER INTRUSION THREAT TO THE PARISH WATER SYSTEM; AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

**WHEREAS**, the Parish of St. Bernard, State of Louisiana (the "Parish" or the "Issuer") has heretofore issued its Taxable Hurricane Recovery Bonds, Series 2021 (the "Bonds") pursuant to Ordinance SBPC #2382-11-21 adopted on November 16, 2021 (the "Bond Ordinance"); and

**WHEREAS**, the Issuer desires to amend the Bond Ordinance to provide an additional purpose, given emergency circumstances, namely the salt water intrusion threat to the Parish's water system;

**NOW, THEREFORE, BE IT ORDAINED** by the Parish Council of the Parish of St. Bernard, State of Louisiana, acting as the governing authority of the Parish of St. Bernard, State of Louisiana, that:

**SECTION 1. Amendment.** Subject to State Bond Commission approval, Ordinance SBPC# 2382-11-21 is hereby amended to provide that proceeds of the Bonds may be used for the additional purpose of expenditures to address the salt water intrusion threat to the Parish's water system.

**SECTION 2. Effective Date.** This ordinance shall become effective immediately upon authorizing signature by the Parish President. If the proposed ordinance is not signed or vetoed by the Parish President within Twelve (12) hours after receipt it shall be considered adopted. As an emergency ordinance, the provisions shall remain valid for a time period of sixty (60) days.
