On motion of Mr. Everhardt, seconded by Mr. McCloskey, it was moved to **adopt** the following **Emergency Ordinance**:

AN **EMERGENCY ORDINANCE** DIRECTING THE PARISH PRESIDENT TO DEDICATE FUNDS THAT ARE CURRENTLY IN THE FIRE CAPITAL FUND TO FIRE STATION 11 FOR REPAIRS.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

SECTION 1. This ordinance will ensure that administration will dedicate funds in the amount up to \$60,000.00 that is currently in the Fire Capital Fund to Fire Station 11 for repairs to become operational.

WHEREAS, St. Bernard Parish Council is desirous to return Fire Station 11 to a complete and functioning status; and,

WHEREAS, the dedicated funds in the amount up to \$60,000.00 will allow Fire Station 11 to become a habitable, operational, and a functioning station once again.

SECTION 2. This emergency ordinance will dedicate the funds specifically to return Fire Station 11 to a complete and functional status to protect the lives and property of the people of District E.

SECTION 3. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. If the proposed ordinance is not signed or vetoed by the Parish President within Twelve (12) hours after receipt it shall be considered adopted. As an emergency ordinance, the provisions shall remain valid for a time period of sixty (60) days.
