A RESOLUTION APPROVING THE PLACEMENT OF A THREE WAY STOP SIGN AT THE CORNER OF DERBIGNY STREET AND PAKENHAM DRIVE, CHALMETTE, LA.

WHEREAS, attached is a letter of recommendation from the Director of Public Works.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority, does hereby approve the placement of a three way stop sign at the corner of Derbigny and Pakenham Drive, Chalmette, La.


