On motion of Ms. Callais, seconded by Mr. McCloskey, it was moved to **adopt** the following resolution:

RESOLUTION SBPC #2328-10-23

A RESOLUTION OBLIGATING FUNDS TO LAND AND WATER CONSERVATION FUND PROJECT.

WHEREAS, the Parish is interested in acquiring lands and/or developing outdoor recreational facilities on the following described project for the citizenry of the Parish and the State of Louisiana; and,

WHEREAS, the Parish is petitioning utilizing only a portion of this existing lot in the creation of an asphalt bikeway/pedestrian nature trail connecting Torres Park to the 40 Arpent Wetland Observatory. Chenier Nature Trail to be a non-loop, two-way meandering and 12' in width asphalt pathway. Site work will include pre-construction clearing and grading activities as well as selective tree clearing of non-native species. Any wiring covered in this project, or wiring done in the future on this site, will be placed underground.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, does hereby agree to obligate the funds or services stipulated below to satisfactory complete the following project and thus become eligible for the U.S. Park Service Land and Water Conservation Fund financial aid of 50% of the estimated or actual allowable cost, at the completion of said project. St. Bernard Parish Council also states that sufficient funds are on hand, as of this date, to fund said project as follows:
