A RESOLUTION RESPECTFULLY REQUESTING ENTERGY, AT&T AND COX COMMUNICATIONS TO COMPLETE THE INSTALLATION OF THEIR UTILITIES ON ALL NEW UTILITY POLES AND ONCE COMPLETE, REMOVE THE PREVIOUS UTILITY POLES THAT EXISTED THERE.

WHEREAS, St. Bernard Parish would like to request Entergy, AT&T and Cox Communications to complete the installation of their utilities on all new utility poles; and,

WHEREAS, currently throughout St. Bernard Parish we have utility poles that are still in place even though service has been transferred to new utility poles; and,

WHEREAS, St. Bernard Parish would like for Entergy, AT&T and Cox Communications to remove any and all utility poles that still exist where new utility poles were installed in St. Bernard Parish.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, the Governing Authority, does hereby respectfully request that Entergy, AT&T and Cox Communications complete the installation of their utilities on all new utility poles and once completed, remove the previous utility poles that existed there.


