AN ORDINANCE TO AUTHORIZE THE PARISH PRESIDENT TO ACQUIRE LOTS 1, 2, 3, 5, AND 6 SQ. 20 and LOTS 55 AND 56 RIVERLAND PARK SUBDIVISION.

**WHEREAS**, Lucas J. Gagliano wishes to sell Lots 1, 2, 3, 5, 6, 55 and 56 of the Riverland Park Subdivision, in the Parish of St. Bernard, LA, 1309 Missouri, 1305 Missouri, 1301 Missouri, and 3104 Volpe to St. Bernard Parish Government; and;

**WHEREAS**, St. Bernard Parish Government wishes to purchase this property, and;

**WHEREAS**, the Parish will pay the agreed upon value of \$539,450.00 and all costs associated with the closing.

Lot 1 in Square 20 commences at a distance of 117 feet from the intersection of Missouri Street and Thelma Street, and measures thence 50 feet front on Missouri Street, same width in the rear, by a depth of 100 feet between equal and parallel lines. Lot 55 forms the corner of Missouri Street and Volpe Drive and measures 69 feet front on Missouri Street, the same width in the rear by a depth and front on Volpe Drive of 71 feet by a depth along the opposite side line of 71 feet.

**SECTION 4.** The following described property as Lots "5" and "6" of Square "20" and Lot "56" – Riverside Park Subdivision, Parish of St. Bernard, Louisiana

THREE CERTAIN LOTS OF GROUND, together with all the buildings and improvements thereon, and all the rights, ways, privileges, servitudes and appurtenances thereunto belonging or in anywise appertaining, situated in the Parish of St. Bernard, State of Louisiana, in Riverland Park Subdivision, in Square No. 20, bounded by Missouri Street, Thelma Street, the southerly boundary of the Twenty Arpent Canal, and the easterly boundary of the subdivision, designated as LOT NO. 5, LOT NO. 6, and LOT NO. 56 and measures as follows:

**SECTION 5.** The St. Bernard Parish Council hereby authorizes the Parish President or his designee to acquire Lots 1, 2, 3, 5, and 6 of Square 20 and Lots 55 and 56 from Lucas J. Gagliano and to execute the Act of Sale and any necessary documents to effectuate the purchase.

**SECTION 6.** Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


