On motion of Mr. McCloskey, seconded by Mr. Randall, it was moved to adopt the following ordinance:

AN ORDINANCE TO AUTHORIZE THE RETENTION OF THE LAW-FIRM BLUE WILLIAMS, L.L.P., TO PROVIDE LEGAL REPRESENTATION FOR ST. BERNARD PARISH GOVERNMENT IN THE CASE OF LMB SERVICES, LLC VS. THE PARISH OF ST. BERNARD GOVERNMENT, CIVIL NO. 23-1617, DIV. "D", 34th JUDICIAL DISTRICT COURT.

**WHEREAS**, St. Bernard Parish Government believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to retain the law-firm Blue Williams, L.L.P. to represent their interests in the above matter.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

**SECTION 1.** The St. Bernard Parish Council, the Governing Authority, does hereby approve and authorize the hiring of private counsel to represent St. Bernard Parish Government solely in the case LMB Services, LLC vs. The Parish of St. Bernard Government, Civil No. 23-1617, Div. "D", 34th Judicial District Court, and any matters related thereto.

**SECTION 2.** Compensation. The compensation shall be made pursuant to the Louisiana Attorney General Billing Rates in connection with legal services performed on behalf of public entities, parishes, and political subdivisions.

**SECTION 3.** Effective Date. This ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto this ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

**SECTION 5.** The Parish President is hereby authorized to enter into a contract for legal services as provided in the attached retention letter and in accordance with section 4-02 (b) of the Home Rule Charter.


